Veterinary conditions:

1. Competing dogs must be clinically healthy. Dogs of the Czech breeders must have valid vaccination cards according to the § 6, par. 3, letter. b of the veterinary law or must have valid passport of the animal in the interest breeding. Dogs of the breeders from EU and from 3rd countries must comply with the regulations of European Parliament and Board No. 998/2003 valid as of 26. 5. 2003.
2. On the competitions there are allowed just the dogs with the valid vaccinations (esp. Valid Rabies shots).
3. Bitches in season and the bitches in the second half of the pregnancy are not allowed to compete.

Participation Conditions:

1. The competition takes place despite any weather conditions. All retriever breeds can participate. Only handlers and dogs complying with the general rules for competition participation can take part. Those conditions are part of the Competing Conditions Order for Hunting Dogs.
2. Bitches in season and ill dogs are not allowed to participate! Handlers must have dog pedigree, valid rabies shots record available at the competition. Dogs which are not able to confirm their pedigree are not allowed to participate as well. (Chip reading device will be available.)
3. Organizer does not guarantee situations such as loss of the dog, death of the dog or damage made by the dog.

**Organizer does not guarantee damage made by the dog or loss of the dog.
The entry fee is non-refundable.**

General Conditions:

- Accommodation is needed to book individually.

In case of the situations which could impact health or lives of participants and their dogs, the organizers has right to cancel the event without any compensation.
